### **Agreement Summary**

This Agreement is made between **Naledi Casting** (“The Agency”) and the **Artist** (the person or guardian submitting their application on the website). By submitting the application, the Artist agrees to the terms stated below.

---

### **1. Parties**

**1.1 The Agency:** Naledi Casting, with its head office at 12 Sprigg Avenue, Tableview, Cape Town, operating in Cape Town, Johannesburg, and Durban.

**1.2 The Artist:** The individual (or parent/guardian) who submits their information via the online joining form.

---

### **2. Preamble**

- The Agency provides services in modelling and casting.
  - The Artist wishes to be represented by the Agency for potential work.
  - The Agency agrees to market the Artist to its client base.
  - Any unauthorised copying or use of this agreement is prohibited.

### **3. Definitions**

- **Agreement** – This document.
  - **Commencement Date** – Date the Artist submits their application.
  - **Duration** – 24 months from the Commencement Date.
  - **Enrolled Artist** – An Artist with current information and updated photographs.
  - **Services** – The Agency promoting and submitting the Artist to clients.
  - **Option** – When the Artist is shortlisted for a job.
  - **Restraint Period** – 6 months after termination where the Artist cannot take similar work without consent.
  - **Monthly Membership Fee** – R50 per month.
  - **Upfront Administration Fee** – R50 once-off.
  - **Commission** – 35% of all earnings.
  - **Tax Deduction** – 25% SARS deduction where applicable.

## 4. Commencement and Duration

This Agreement is valid for 24 months from the Commencement Date unless terminated earlier as per Clause 8.

---

## 5. Fees and Commission

- R50 once-off Administration Fee
- R50 Monthly Membership Fee to be on the site
- 35% Commission on all earnings
- 25% SARS tax deduction where applicable

 **Note:** The Artist must ensure personal tax compliance with SARS.

---

## 6. Portfolio Management

The Artist must provide the following and keep it updated:

- 2 headshots
  - 2 full-length shots
  - 1 character shot
  - Current clothing sizes and body measurements
- 

## 7. Audition Attendance

**7.1** If the Artist confirms an audition or casting and fails to attend without reasonable notice, a **penalty of R500** may be charged.

**7.2** Repeated no-shows may result in suspension or termination of the Artist's profile.

---

## 8. Termination

- This is a fixed 24-month agreement.
  - Either party may terminate in writing.
  - Termination is valid once confirmed in writing by both parties.
  - All outstanding amounts must be paid upon termination.

## 9. Restraint of Trade

The Artist may not accept similar work for 6 months post-termination from any client or contact of Naledi Casting without written permission from the Agency.

---

## **10. Jurisdiction**

This Agreement is governed by South African law. Disputes will be handled in the Cape Town jurisdiction.

---

## **11. Entire Agreement**

This document constitutes the entire agreement between the Artist and Naledi Casting. No other verbal or written agreements will be binding unless agreed to in writing and signed by both parties.
